Description			

Provide a short description of the event and its activities.

Participants began arriving on the evening of October 24th, 2024, for a welcoming dinner at the ic-Centru restaurant in Gharb Square, Malta, starting at 19:00. This provided an informal setting for attendees to meet and network before diving into the workshop sessions the next day. The dinner allowed participants to familiarize themselves with each other and set the stage for collaboration during the upcoming sessions.

The morning of October 25th began with breakfast at the hotel, where participants gathered at 09:00 at the pool area. At 10:00, the host officially welcomed the attendees and outlined the main objectives of the workshop. These included the development of intercultural dialogue, sharing good practices for empowering the unemployed through active citizenship, and strengthening connections with local authorities. The discussions also focused on the relationships between local, national, regional, and European forms of participatory citizenship, particularly how barriers could be overcome to ensure that European citizens, despite their diversity, could engage more effectively at various levels.

The first session, beginning at 10:15, featured a presentation on Malta's approach to intercultural dialogue and the exchange of knowledge and experiences. This was followed by a presentation from Romania at 10:45, Croatia at 11:15, and Slovenia at 12:00. The presentations offered crucial points into the unique strategies and challenges each country faced in fostering participatory citizenship.

At 11:45, participants took a coffee break, providing an opportunity to reflect on the morning sessions and engage in informal discussions. The group reconvened for lunch at 13:00 before embarking on the afternoon session, which started at 14:30. This workshop focused on the connection between local authorities and citizens, examining how participatory citizenship can be fostered within local, national, regional, and European frameworks. The session addressed current challenges and explored solutions for improving the relationship between government institutions and citizens, with an emphasis on local governance.

At 15:45, the results from the afternoon workshop were presented and debated, providing a platform for participants to share their findings and engage in critical discussions on how to improve citizen participation. The day concluded with a dinner at 19:00 at the ic-Centru restaurant, allowing participants to unwind and socialize after a day of intensive dialogue.

On the second day, after breakfast at 09:00, the group reconvened for the first workshop at 10:00, which focused on overcoming barriers to European participatory citizenship. This workshop took into account the quantity and diversity of European citizens and aimed to identify and address the obstacles preventing full engagement in citizenship processes. Participants worked together to develop strategies for making citizenship more inclusive and accessible across Europe.

At 11:00, the results from the workshop were presented, allowing participants to discuss the proposed solutions and gain insights into how these ideas could be implemented at various levels. Following this session, participants enjoyed lunch at the hotel at 13:00.

In the afternoon, the group visited the local council at 14:30, where they had the opportunity to discuss good practices for participatory citizenship directly with local authorities. This visit provided real-world examples of how local governments can engage with their citizens and implement policies that foster active citizenship. The session allowed participants to see the practical application of the ideas discussed in the workshops.

The day ended with a dinner at 19:00 at the ic-Centru restaurant, where the discussions continued in a more informal setting.

The final day began with breakfast at 09:00. Afterward, participants prepared for their departure, marking the conclusion of the workshop. This day provided an opportunity to reflect on the outcomes of the event and the key takeaways. The discussions throughout the workshop highlighted the importance of intercultural dialogue, the exchange of best practices, and the development of strategies to overcome barriers to participatory citizenship at local, national, and European levels.
